This contract (the "Agreement") is entered into between Ledgewood Boarding Inc. hereinafter referred to as the "Pet Boarding Company," "We," or "Our") and ________(hereinafter referred to as the "Pet Owner," "You,"

PET BOARDING SERVICES

Ledgewood Boarding Inc. will provide a safe, clean, and caring environment for the pet(s) throughout the duration of the services. This includes ensuring that adequate shelter, comfortable bedding, sufficient food, and clean water are readily available to promote the pets(s)' well-being. Ledgewood Boarding Inc. acknowledges and agrees to adhere to the feeding schedule and dietary requirements specified by the pet Owner. Appropriate provisions will be made to ensure that the pets(s) receive the necessary physical activity, playtime, socialization, and companionship. The pets(s)' medications will be administered according to the pet Owner's explicit instructions.

PET OWNER RESPONSIBILITIES

The pet Owner should ensure that their pet(s) have the appropriate ID tags and collars for identification. The pet Owner should ensure the health of their pet(s) before check-in. The pet(s) should be free from contagious diseases for at least 14 days prior to their stay, and the pet(s)' vaccinations and flea/tick prevention should be current. The pet Owner will provide clear and detailed instructions for any required medications or special dietary needs, and any medications should be properly labeled. Any known pet behavioral issues or aggression triggers must be disclosed to Ledgewood Boarding inc. This information is essential for the safety of both the pet and boarding staff. Certain risks are involved in boarding, including but not limited to fights, bites to humans or other animals and the transmission of disease. Any medical expenses will be pet owners responsibility. Pets with fleas will be treated with a Capstar tablet at owners expense.

Holiday Closures:

Pet caregivers are on hand for normal operations everyday even on days when our boarding facility is closed. Our office is closed for pick-up/drop-off hours on the following holidays: New Years Day, Easter, Memorial Day, 4th of July, Labor Day, Thanksgiving, Christmas Eve & Christmas Day.

We have limited hours on New Year's Eve, Easter Eve, & Thanksgiving Eve

PAYMENT AND FEES

The Pet Owner agrees to pay Ledgewood Boarding Inc the boarding fee as previously discussed and agreed upon. All charges must be paid in full upon pick up of your pet. There is a \$25.00 returned check fee. Pet's left 10 days beyond the agreed pick up date will become property of Ledgewood Boarding Inc and may be removed with Ledgewood Boarding inc discretion.

Additional services, such as grooming, add on services, medication administration and transportation, will be subject to additional fees. The Pet Owner will be responsible for the payment of these additional service fees.

The Pet Owner acknowledges that the late pick-up of their pet(s) beyond the agreed-upon check-out date and time will result in additional fees, which are assessed either on a per-day or per-hour basis. Pets picked up early without notification may be subject to the charges for the number of days remaining on this contract. No-show to confirmed reservations will be subject to a no-show fee

CANCELLATION AND TERMINATION

To cancel or alter the services, the Pet Owner is required to provide at least a 48hour notice prior to the check-in date. If a cancellation is made after this period, there will be a cancellation fee. Ledgewood Boarding Inc reserves the right to cancel or terminate services at any time due to reasons that may include but are not limited to aggressive pet behavior or false information provided. Should Ledgewood Boarding Inc cancel the Services, the Pet Owner will be notified promptly. In case of termination, the Pet Owner may not be entitled to a refund of any balance due.

EMERGENCIES

In the event of a pet medical emergency, every reasonable effort will be made to contact the Pet Owner or emergency contact immediately. If this cannot be done in time, Ledgewood Boarding Inc. is authorized to seek the veterinary care necessary for the pet's health and safety. The Pet Owner is responsible for all associated veterinary expenses. The fees for emergency vet visits (in addition to the veterinary charges) are based on the travel expenses and time required by staff.

LIABILITY

The Pet Owner agrees to indemnify and hold harmless Ledgewood Boarding Inc from any claims, liabilities, damages, expenses (including legal fees), or harm to the pet(s) arising from the services, except in cases of gross negligence or willful misconduct.

ENTIRE AGREEMENT

This contract constitutes the entire agreement between the Pet Owner and Ledgewood Boarding Inc. regarding the services and supersedes all prior discussions, understandings, representations, and agreements, both written and verbal.

ELDERLY DOGS:

Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes on while in our care, our policy is to transport Owner's dog to Owner's vet (within 15 miles) where he/she will be held until Owner can be reached by the Vet for further instructions. If Owner's vet is closed or outside of our transport distance, then we will transport to nearest 24-hour facility. Trip charge will apply based on time/distance.

SEVERABILITY

If any provision of this Agreement is found to be invalid, illegal, or unenforceable under applicable law, the invalidity, illegality, or unenforceability of such provision shall not affect the validity or enforceability of the remaining provisions of this Agreement.
